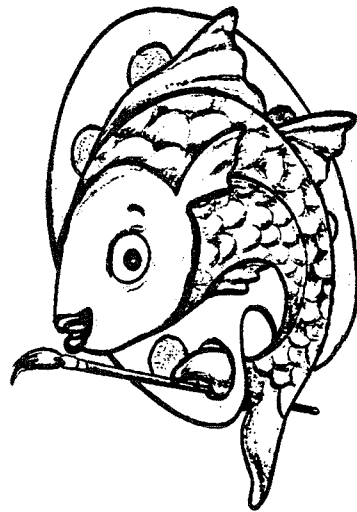

The Eastern Shore Chamber of Commerce is pleased to invite you to the 21st Annual Jubilee Festival. This two-day event offers an exciting opportunity to view and acquire works of participating artists and crafters from throughout the country, while offering fun for the entire family. It is also a great opportunity for us to showcase Daphne, the Eastern Shore, as well as Baldwin County.

The Jubilee Festival is sponsored by the same organization as its sister event, the Arts & Crafts Festival in Fairhope, which is in its 57th year in 2009 and is usually held the third weekend in March.

Located in Daphne, the heart of the Eastern Shore, the Jubilee Festival has evolved with a separate unique identity, yet it has benefited from the experience and strong foundation of the Arts & Crafts Festival. The Eastern Shore Chamber of Commerce has succeeded in creating another premier arts and crafts event on the Eastern Shore.

Approximately 130 spaces will be available for the varied selection of fine art and craft exhibits. Designated streets will be blocked to accommodate the festival, which is expected to attract over 37,000 visitors.

A Food Court will serve a tempting array of food and beverages throughout the weekend. Local merchants and restaurants join the Eastern Shore Chamber of Commerce and the City of Daphne in making this a truly outstanding festival.

Location

The 21st Annual Jubilee Festival will be held in Daphne, Alabama, the heart of the Eastern Shore. Daphne is directly across Mobile Bay from Mobile, Alabama, at the interchange between Interstate 10 and U.S. 98 (Exit 35). The Festival is located in "Olde Towne" Daphne on Main Street, 5 miles south of Interstate 10. Show hours are **10a.m. to 5p.m., Saturday and 10a.m. to 5p.m. September 26th and Sunday, September 27th.** Local merchants and restaurants join the Eastern Shore Chamber of Commerce and the city of Daphne in making this a truly outstanding festival.

Booth Spaces

For safety reasons, artists and crafters must confine themselves to the 10' x 12' space. No more than two booth spaces may be reserved per exhibitor. Approximately 130 spaces will be available for the wide selection of fine art and craft exhibits.

Exhibitors' Lunch

Lunch will be provided on **Saturday, September 26th.** Each exhibitor will be given one complimentary box lunch which will be delivered to your booth. Additional lunches can be purchased at registration.

Entry Fee

The charge for a booth is **\$100.00** (\$85.00 for Eastern Shore Chamber of Commerce members) plus a **\$20.00 non-refundable jury fee.** Please send separate checks. No commission is charged on sales. The booth fee is returned if your application is not accepted. **An accepted application is a commitment to the show and no refund will be made for cancellations (no exceptions).** No fee will be refunded due to inclement weather. Subletting of booth space is not allowed.

State/County Business License

The State of Alabama and Baldwin County require each exhibitor and vendor to purchase a transient business license. The details are available from the Baldwin County License Inspector at (251) 990-4631.

Deadline: June 12, 2009

Applications must be postmarked by **June 12, 2009.** Selection notifications will begin **June 26th.** Late applications will be considered if classification is not full, with final approval from the jury committee. If the category is full, and the application is not juried, the applicant will receive a full refund.

Selection

The Jury Committee for the Jubilee Festival selects exhibitors deemed to best reflect creativity, quality and originality. Selection is made on the basis of **THREE recent images on a computer disc,** representative of the artist's/crafter's work and **ONE** image on the disc of your booth or display. Jury consideration will be based only on the images of work and display, not on any other qualifications. **Samples will not be considered nor returned. Print your name clearly on the computer disc.**

Please remember that selection can only be based on the images you send, so it is important that the images be of good quality. In an effort to maintain a balanced show, the number of exhibitors in each category is limited. In case of a large number of what appears to be equally acceptable entries in a particular category, preference will be given to those applications received first.

Standards

1. An accepted application is a commitment to show and no refund will be made for cancellations. No Exceptions.
2. Under no circumstances will stand-in or proxy exhibitors be permitted. Only the artist or crafter accompanying his or her original work may participate in the Jubilee Festival.
3. Artists and crafters must exhibit the two (2) days of the festival. Artists and crafters are required to man their exhibits during festival hours.
4. Commercially manufactured items (i.e. finished ceramics, jewelry, commercial molds, patterns or kits) are not acceptable. All items must be hand-crafted by the applicant. Exhibitors displaying commercial items will be asked to remove them.
5. 25% of the work displayed must be originals and must be for sale. Photo-offset reproductions of the exhibitor's originals may be displayed, but must be designated as such.
6. Exhibitors bear the responsibility for all set-up and security needs for their exhibits. Neither the Eastern Shore Chamber of Commerce, its representatives, nor the City of Daphne, Alabama, will be responsible for loss or damage of any kind.
7. Artists and crafters must provide their own display booths, racks, tables and chairs, and should be prepared for the possibility of inclement weather conditions, such as wind or rain.
8. No space can be shared, but one artist can purchase two spaces. A "multi-person" team producing a single product may qualify as a single exhibitor.
9. No on-site gas power generators are allowed. No amplified music permitted.
10. This is a family-oriented festival for spectators of all ages, and work exhibited must be in keeping with this atmosphere. The Festival reserves the right to remove work that it deems inappropriate.
11. **NONCOMPLIANCE WITH FESTIVAL STANDARDS & RULES MAY RESULT IN ELIMINATION FROM THIS YEAR'S AND FUTURE FESTIVALS WITH NO REFUND OF FEES.**

Judging

Judging will begin Saturday at 10:00a.m. The judges reserve the right to travel the show and evaluate the exhibits in the manner they choose. A "spotter" is assigned to follow the judges and mark the booth to indicate that the exhibit has been judged.

Awards

A combination of cash and patron's awards, along with ribbons make up the 55 awards which will be judged on Saturday.
