\$220.00 base (includes first 5 employees)
 6 - 50 employees - \$10.00 per employee, plus base
 51 - 100 employees - \$8.50 per employee, plus base
 101 - 200 employees - \$6.50 per employee, plus base
 201 employees & over - \$4.00 per employee, plus base

NOTES:

- *Two part-time employees equal one full-time employee.
- **One membership includes ONLY one physical listing in the membership directory and one mailing address.

Homebased Business... \$200.00

Banks and Credit Unions...

\$550.00 minimum, plus \$10.00 per million dollars in deposits in the Eastern Shore Chamber area.
